**CONFIDENTIALITY:** In compliance with general ethical practice and the Protection of Personal Information Act complete confidentiality is guaranteed and maintained. Any information revealed during therapy will not be provided to another party without the client's/clients' explicit consent with stipulated permission as to what information will be conveyed to whom. The only exception might be in extraordinary cases because of inevitable legal and/or ethical obligations.

**RELATIONSHIP:** Relationship/-s in therapy are characterized by mutual respect, trust, understanding, warmth, empathy, acceptance, honesty, involvement and active listening.

**COOPERATION:** All parties involved in the therapeutic process enter into an agreement of cooperation, interdependence, mutual trust and credibility, as well as to adhere to therapy session times as agreed and to be financially accountable.
